PURPOSE OF VISIT:

Our classes visited the Etikopakka toy Industry to gain insights into the traditional toy - making process and understand the cultural significance of this craft in the region

SUMMARY OF FINDINGS:

1 . Traditional craftsmanship:

The visit provided us with a firsthand experience of the traditional craftsmanship involved in the making of toys in Etikopakka . We observed that all the artisans employed in the Industry were women . They are meticulously crafting wooden toys using age - old techniques passed down through generations.

2 . Use of Natural materials:

They use the wooden sticks which are called "Ankudu" stick which is transported from the forests of Narasipatanam and they also use natural dyes . This not only adds to the eco-friendliness of the toys but also highlights the sustainable practices followed by the artisans.

3 . Community Impact :

The industry plays a vital role in supporting the local economy and preserving traditional craftsmanship . By providing employment opportunities to local artisans , it contributes to the socio-economic development of the region .

4 . Markets :

These toys are exported internationally . It has a wide markets throughout the world like china , Japan ,etc

RECOMMENDATIONS:

* Skill Development:

Investing in skills development programmes for artisans would not only help in preserving traditional crasfsmanship but also empower them with new techniques and technologies to stay competitive in the markets .

*Enhancement of Markets :

The government should enhance these markets . Government should install atleast some industries like these which help in improvement of economy , job opportunities , wider markets , preservance of traditions, etc .

CONCLUSION:

The visit to Etikopakka toy industry was a enriching experience that provided us with valuable insights into the rich cultural heritage and craftsmanship of the region . It underscored the importance of preserving traditional crafts while also embracing innovation for sustainable growth . 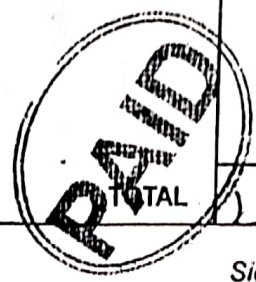
